US PRIVACY

- California Zoom Class Action: On March 31, 2020 Wexler Wallace LLP filed a class action suit against Zoom Video Communications for allegedly collecting the personal information of its users and disclosing such information to third parties, including Facebook. A copy of the class action can be found here.. Also, on March 31, 2020 Senator Richard Blumenthal sent Zoom a letter to seek additional information about how Zoom handles personal data of its users and protects against security threats and abuse against its services. - Maryland: House Bill (HB 1202) was introduced to the Governor to prohibit employers from using
 certain facial recognition services during an applicant's interview for employment unless the
 applicant consents. HB 1202 would require an employer to obtain the consent of an applicant
 seeking employment to sign a waiver to use certain facial recognition service technologies during an

- United States FTC Settles Claims Against Ortho-Clinical Diagnostics, Inc. Over False Claims Of Privacy Shield: On March 30, 2020 the Federal Trade Commission (FTC) announced that it had settled allegations against Ortho-Clinical Diagnostics, Inc. which had claimed to participate in the EU-US Privacy Shield. Ortho's certification application with the Privacy Shield had lapsed with the Department of Commerce in 2018, and they had not completed steps to continue their participation in the framework. The settlement included that Ortho-Clinical Diagnostics, Inc. is prohibited from making any further misrepresentations over the Privacy Shield, and any other privacy or data security program sponsored by the Government, or any self-regulated or standard-setting organization. The Consent Agreement will be posted in the near future for public comment, and the Proposed Settlement can be found here.
